 2. All driving must be by the most direct route possible.
 3. Financial responsibility must exist for your operation of this vehicle, and proof must be presented with this order, or this order is not valid.
 4. This order is not the same as having a valid operator's license. If you are stopped by a law enforcement officer, it is your responsibility to demonstrate compliance with this order. If you are unable to do so, you may be issued a traffic citation or arrested.
 5. This order does not grant privileges for operating a "Commercial Motor Vehicle" as defined by RC 4506.161.
